# The Federation of Tiverton Schools Publication Scheme on information available under the Freedom of Information Act 2000

## 1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish;
- The manner in which the information will be published;
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is either available for you on our website to download and print off or in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

## 2. Aims and Objectives

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as "classes". These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

- School Prospectus information published in the school prospectus.
- The School Profile and other information relating to the governing body information published in the School Profile and in other governing body documents.
- Students & Curriculum information about policies that relate to students and the school curriculum.
- School Policies and other information related to the school information about policies that relate to the school in general.

Curriculum Intent Statement	Statement on following the policy for the secular curriculum subjects and religious education schemes of work and syllabuses currently used by the school.
Sex & Relationship Education Policy	Statement of policy with regard to sex and relationship education.
Special Education Needs and Disabilities Policy	Information about the school's policy on providing for students with special educational needs.
Accessibility Plan	Plan for increasing participation of disabled students in the school's curriculum, improving the accessibility of the physical environment and improving delivery of information to disabled students.
Equality Statement	Statement of policy for promoting all forms of equal opportunities including race, gender and additional needs.
Collective Worship Policy	Statement of arrangements for the required daily act of collective worship.
Careers Education, Information, Advice & Guidance Policy	Statement of the programme of careers education provided for Y10 & Y11.
Safeguarding and Child Protection Policy	Statement of policy for safeguarding and promoting welfare of students at the school.

Staffing Structure Implementation Plan	The school's plan for the implementation of any changes to its staffing structure following statutory review.
Curriculum circulars and statutory instruments	Any statutory instruments, departmental circulars and administrative memoranda sent by the Department of Education and Skills to the head teacher or governing body relating to the curriculum
Admissions policy	Statement of the school's policy on admissions.
